# SAINT LUCIA

STATUTORY INSTRUMENT, 2020, No. 91

[ 12th June, 2020 ]

In exercise of the power conferred under section 3 of the Emergency Powers (Disasters) Act, Cap. 14.07, the Minister responsible for disaster preparedness and prevention makes this Order:

## **Citation**

1. This Order may be cited as the Emergency Powers (Disasters) (COVID 19) (Curfew) (No. 9) Order, 2020.

## **Interpretation**

2.—(1) In this Order —

“curfew” means the time specified under section 3;

“full operation” means operating a service in accordance with the physical distancing protocols specified under section 7 in the normal location and within the customary time;

“public service” means a public service under section 5;

“service” means a service under section 4.

(2) A word that is defined in the Emergency Powers (Disasters) (COVID 19) Order, Statutory Instrument No. 42 of 2020 has the same meaning in this Order.

## **Curfew**

3. A curfew is imposed each day on the 15<sup>th</sup> day of June, 2020 to the 30<sup>th</sup> day of September, 2020 from 12 a.m. to 5 a.m.

## **Operation of services**

4. Except during the curfew, a service is open for full operation.

**Operation of public services**

5. Except during the curfew, a Government agency is open for full operation.

**Essential services to operate during curfew**

6.—(1) A service or public service that is an essential service shall operate with the written permission of the competent authority during the curfew.

(2) An essential service that operates under subsection (1) shall be issued with a pass by the Director of the National Emergency Management Organization.

(3) An essential service under subsection (1) shall comply with the physical distancing protocols specified under section 7.

(4) In this section, “essential service” has the meaning assigned under section 10(4) of the Emergency Powers (Disasters) (COVID 19) Order, Statutory Instrument, No. 42 of 2020.

**Physical distancing protocols**

7. A service or public service shall —

- (a) ensure that all customers and staff maintain physical distancing of no less than six feet —
  - (i) in the business or office, or
  - (ii) outside the business or office, if required;
- (b) determine the number of persons that may be permitted in the office at any one time by permitting one person for every thirty square feet of space.

**Confinement to residence**

8.—(1) In an effort to prevent the spread of COVID 19, a person other than a person under sections 4, 5 and 6 shall remain confined in their place of residence to avoid contact outside of their family during the curfew.

- (2) Subsection (1) does not apply to necessary travel —
- (a) to an essential service that is in the closest proximity from where the person resides; or
  - (b) by essential service personnel.

**Educational institutions**

**9.—**(1) All educational institutions shall remain closed.

(2) Subsection (1) does not prohibit any activity that can be performed by electronic or virtual means.

(3) In subsection (2), “activity” includes teaching and learning.

(4) Notwithstanding this section an educational institution shall, on its premises and in accordance with the physical distancing protocols under section 7, provide teaching and learning to —

- (a) Grade Six students for the Common Entrance Examination;
- (b) Form Five students and private candidates for the Caribbean Secondary Education Certificate Examinations.

(5) An educational institution that provides teaching and learning under subsection (4) —

- (a) is open from the 2<sup>nd</sup> day of June, 2020 to the 3<sup>rd</sup> day of July, 2020; and
- (b) in the case of the administration of the Caribbean Secondary Education Certificate Examinations, may be open until the 7<sup>th</sup> day of August, 2020, if required.

**Restriction on social activities**

**10.—**(1) A person shall not host or attend —

- (a) a tournament and contact sporting event;
- (b) a social event including the cinema and mass crowd events.

- (2) A faith-based organization may hold a religious ceremony —
  - (a) in accordance with the physical distancing protocols specified under section 7; and
  - (b) if the Ministry of Equity, Social Justice, Local Government and Empowerment, after consultation with the Chief Medical Officer, has approved a COVID 19 Response Plan prepared by the faith-based organization.
- (3) A person may hold or attend a social activity, such as a party, picnic, wedding, reception and banquet in accordance with the physical distancing protocols specified under section 7.

**International travel**

- 11.—(1) All airports are open to incoming international flights.
- (2) All sea ports are open to regional and international seafaring.
- (3) A person may enter and disembark for any reason, including transiting through Saint Lucia.
- (4) Subsections (1), (2) and (3) apply to —
  - (a) outgoing flights or outgoing ships;
  - (b) cargo flights or cargo ships;
  - (c) commercial courier flights;
  - (d) emergency medical flights;
  - (e) emergency flights approved by the Civil Aviation Authority.
- (5) Notwithstanding this section —
  - (a) except with the written permission of the competent authority, sea ports are closed to private boating;
  - (b) the competent authority may impose travel restrictions, if required.

**Restriction on road traffic**

**12.**—(1) A person shall not drive a vehicle on a public or private road during the curfew except with the written permission of the Director of the National Emergency Management Organization.

(2) The Royal Saint Lucia Police Force shall have the power to stop a vehicle and enquire as to the purpose for which that vehicle is being utilized.

(3) In this section, “vehicle” includes a motor vehicle or motorcycle.

**Restriction on visitation**

**13.** Except with the permission of the Chief Medical Officer, a person shall not visit or be permitted to visit a person placed in isolation.

**Disposal of intoxicating liquor**

**14.** A person with a valid liquor licence may expose for sale or dispose of intoxicating liquor in accordance with the Liquor Licence Act, Cap. 13.17.

**Wearing of masks or other covering**

**15.** In an effort to prevent the spread of COVID 19, a person shall wear a mask or other covering fitting over the nose and mouth when in public.

**General penalty**

**16.** A person who contravenes this Order commits an offence and is liable to imprisonment with or without hard labour for a term not exceeding six months or a fine not exceeding one thousand dollars or both and forfeiture of goods or money in respect of which the offence has been committed.

**Revocation**

**17.** The Emergency Powers (Disasters) (COVID 19) (Curfew) (No. 8) Order, Statutory Instrument, No. 78B of 2020 is revoked.

**18.** This Order ceases to have effect when the declaration of state of emergency pursuant to which this Order has been made ceases to have effect.
