### **MOTION**

By the Honourable Prime Minister and Minister for Finance, Economic Growth, Job Creation, External Affairs and the Public Service:

1. **BE IT RESOLVED** that Parliament by affirmative resolution approves the draft Value Added Tax (Amendment of Schedules 1 and 3) Order which amends Schedules 1 and 3 of the Act –

- (a) in the case of Schedule 1 -
  - (i) under item 1, to include a definition for the words "educational supplies",
  - (ii) under item 2 (2), to include the supply of printing of educational supplies as a zero rated supply of service;
- (b) in the case of Schedule 3, to exempt imports of personal items, food, clothing, toys and other household commodities, contained in barrels.
