- i. audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last three (3) years (2022, 2023, 2024) prior to bid submission deadline, demonstrating the current soundness of the Bidder's financial position. For a joint venture, this requirement shall be met by each member;
- ii. Average annual turnover over the last 3 years of minimum of 1.5 times the total value of lots tendered for;
- iii. Access to lines of credit / financial sources of minimum of the total value of lots tendered for.
- (b) **Specific Experience**: The Bidder shall demonstrate that it has successfully completed at least two (2) contracts within the last five (5) years prior to bid submission deadline, each with a value of at least the amounts shown below, that have been successfully and substantially completed and that are similar in nature and complexity to the Goods and Related Services under the Contract. For a joint venture, this requirement may be met by all members combined.
