In exercise of the power conferred under section 193 of the Motor Vehicles and Road Traffic Act, Cap.8.01, the Minister responsible for transport makes these Regulations:

Citation

1. These Regulations may be cited as the Motor Vehicles and Road Traffic (Fees) (Amendment) Regulations, 2015.

Interpretation

2. In these Regulations, “principal Regulations” means the Motor Vehicles and Road Traffic (Fees) Regulations, Cap. 8.01.

Amendment of regulation 2

3. Regulation 2 of the Motor Vehicles and Road Traffic (Fees) Regulations, Cap. 8.01 is amended by deleting regulation 2 and by substituting the following-

“Fees

2. The fees payable under the Motor Vehicles and Road Traffic Act, Cap.8.01 are as specified in the Schedule to these Regulations.
